

**THE CORPORATION OF THE TOWNSHIP OF CRAMAHE  
BY-LAW 2011-66**

**BEING A BY-LAW TO PROVIDE FOR THE BILLING AND  
COLLECTION OF WATER CHARGES FOR 2012.**

**WHEREAS**, the Municipal Act, S.O. 2001, c25, Part 12 provides for a Municipality to pass by-laws imposing fees or charges on any class of person for services or activities provided or done by or on behalf of it;

**AND WHEREAS**, notice of the proposed passing of the by-law and the Council meeting at which the By-law was to be considered by Council was posted on the Township's web-site and placed in the Northumberland Today on November 24<sup>th</sup>, 2011;

**AND WHEREAS**, The Council of the Corporation of the Township of Cramahe has approved the charging of monthly, bi-monthly, quarterly or half-yearly flat rates for users of the water from The Corporation of the Township of Cramahe.

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CRAMAHE  
ENACTS AS FOLLOWS:**

1. THAT all water rate charges shall be billed as separate items on the tax bill and/or water bills and/or electrical bills issued by the corporation or other companies that the corporation contracts out to.
2. THAT nonpayment of any water charges by the due date set out on the bill shall be subject to a penalty equal to 1 ¼% per month.
3. THAT a water rate charge imposed upon any owner or occupant of land is a lien or charge upon the land, and, if the rate or any part thereof remains unpaid after the due date, the unpaid amount including any penalty that is due and payable, may be collected in the same way as municipal taxes are collectable or otherwise, as provided by law.
4. THAT Section "A" Water Rates for the Year 2012 shall form and be part of the By-law.
5. THAT this By-law repeals and replaces any previous by-law and/or schedules pertaining to the Water Fees.

This By-law will come into force and effect, on the 1<sup>st</sup> day of January 2012.

This By-law is given a FIRST, SECOND and THIRD READING and FINALLY PASSED this 6<sup>th</sup>, day of December 2011.
